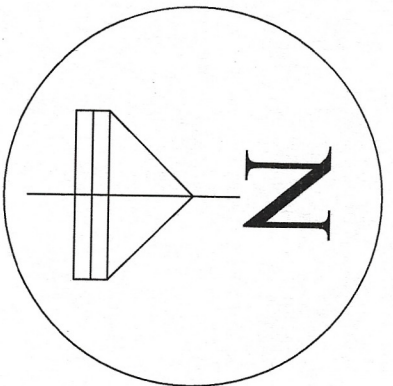


TENTATIVE REVISED LAY OUT PLAN FOR DEVELOPMENT OF INDUSTRIAL SECTOR-13 & 15

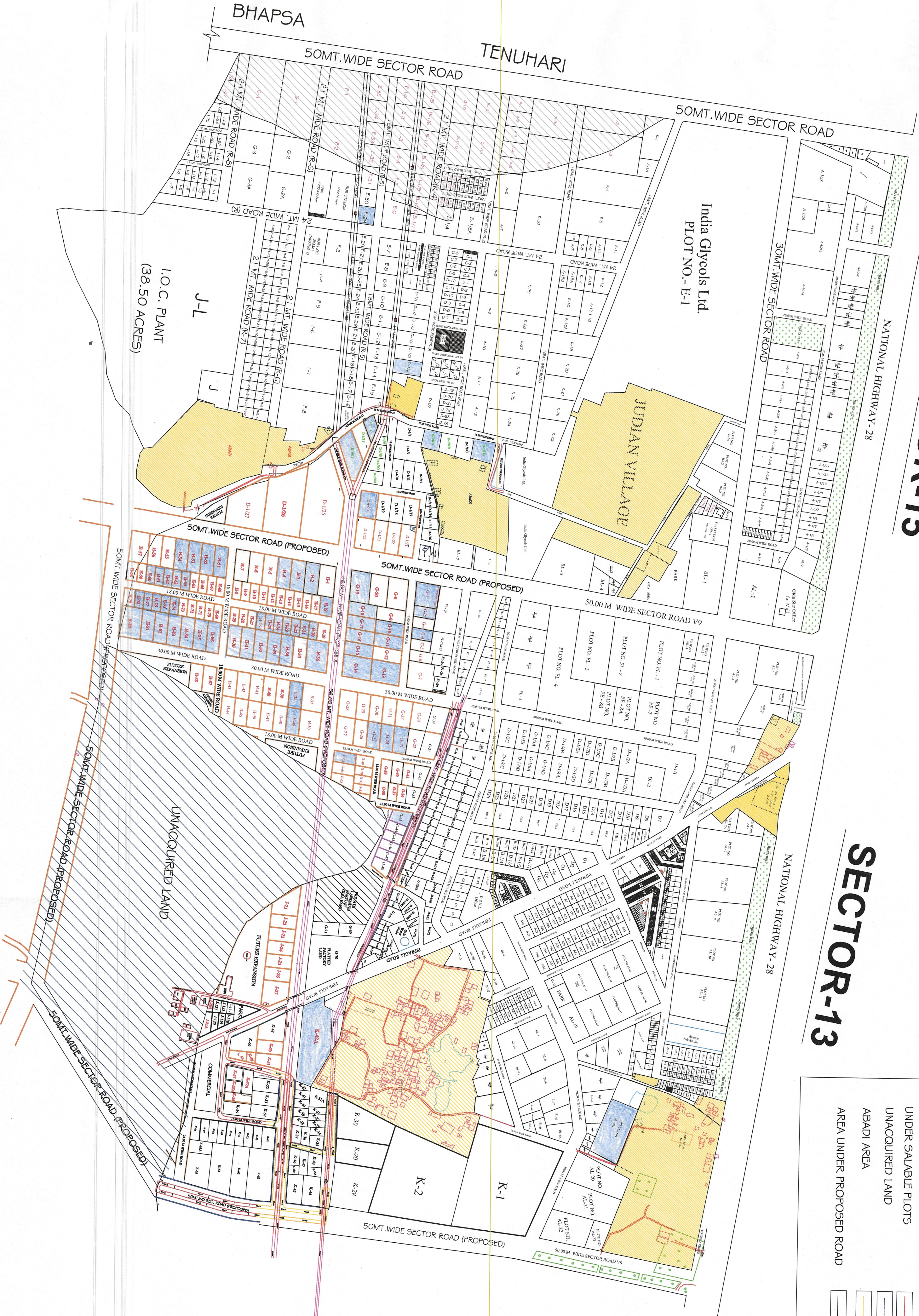
